



For good and valuable consideration, the receipt and legal sufficiency of which are hereby acknowledged, I (the "Model") hereby irrevocably acknowledge and agree in favor of the photographer or artist named below (the "Photographer"), and those persons acting with the Photographer's authority and permission including the Photographer's heirs, executors, legal representatives, licensees, successors and assigns, those for whom the Photographer may be acting (collectively, the "Authorized Parties") as follows:

1. Images

In the event Images including or depicting the Model whether intact or in part or any other graphical depictions incorporating the Model's likeness are taken or created by or on behalf of the Photographer in any media during the session dates listed below (collectively, the "Images"), all worldwide right, title and interest in and to the Images and all related materials including copyright, all other intellectual property and all other proprietary rights shall be owned by the Photographer or as the Photographer may determine.

2. Grant of Rights

The Model hereby grants to the Photographer and each of the Authorized Parties the irrevocable right to use, publish, reproduce, create derivative works of, distribute, publicly perform and publicly display, either digitally or in any other medium now known or later developed, such Images in any form. The Model acknowledges and agrees that all uses shall be without further compensation to the Model. The Model consents to use of the Model's name or any fictitious name in connection with the Images. The Model also irrevocably waives any right that the Model may have to inspection or approval of any uses, whether commercial or private, of the Images. In consideration of the Model's consent and release, the Photographer will use reasonable commercial efforts to ensure that the Images will not be used for any pornographic, obscene, defamatory or libelous purpose.

3. Ownership

The Model acknowledges and agrees that the Images, and all right, title and interest in and to the Images, including all copyright and other intellectual property rights, and all rights in and to the physical Images themselves and all reproductions or digital derivations, are the sole property of the Photographer. The Model agrees that the Photographer may in his or her sole discretion protect the copyright and other intellectual property rights relating to the Photographs, and dispose or authorize the use of any or all such rights in any manner whatsoever.

4. Release and Indemnity

The Model hereby irrevocably releases and indemnifies the Photographer and each of the Authorized Parties from any liability, costs or expenses (including attorney fees) arising by virtue of any claim or cause of action, now known or later developed, resulting from or in connection with any use of the Images including without limitation, any claims for libel, defamation, invasion of privacy, blurring or distorting or altering in any way whether or not intentional, or breach of publicity or other property rights.

The Model and Photographer each hereby warrant that he or she has (i) read this Agreement prior to execution, and is fully familiar with the contents of this Agreement; (ii) that he/she is of full legal age and has the right and capacity to contract in their own name in their jurisdiction of residence; (iii) if a parent or guardian is signing for the Model, that the person or persons signing have full authority in the jurisdiction in which the Release is executed to sign this Release on behalf of the Model; (iiii) if acting as an employee of a company or other entity, the person or persons signing this Release have authority to bind the company or other entity. This Agreement shall be binding on the agents and representatives, executors, licensees and sublicensees, assigns, heirs and successors of each of the Model and the Photographer.
